

Each year, PHA's Quality and Research Committee creates priorities and implements a research agenda on many critical population health topics. Examples of recent Q&R priorities include:

- Impact of population health on valuebased care, revenue and cost, member and provider satisfaction/loyalty, and operational efficiencies
- Advancing strategies to drive consumer engagement to optimize individual/ population health
- Taking action on Social Determinants of Health as levers to provide value to consumers and organizations

GOVERNMENT AFFAIRS COMMITTEE

The Population Health Alliance educates key stakeholders and policy-makers, and advocates for, and contributes to, shaping policies that prioritize the health and wellbeing of populations through:

- Reducing barriers to high-value workplace health and wellness benefits and programs for employees;
- Ensuring that all individuals have stable access to affordable choices in selecting their health benefits;
- Encouraging community-based efforts and support of programs that address medical and social determinants to promote health and well-being in vulnerable populations;
- Supporting individuals' active engagement with their care teams and limiting non-care-related burdens and distractions for both patients and providers;
- Emphasizing research and quality in the delivery of health and wellness benefits and programs to individuals; and
- Continuously introducing innovative solutions to create positive experiences.



NEW PHA WORKGROUPS

Begining in November 2021, PHA had launched a series of new workgroups that will bring more opportunities for leadership, content, and deliverables to the organization. ANNUAL PHA MEMBERSHIP & DUEȘ Categories

PHA Membership is now open to all For-Profit Companies and national Non-Profit Organizations which have an interest in population health management. Recently, we have streamlined our membership application process, reducing the number of corporate membership categories offered. PHA membership is still built upon a tiered-dues structure based upon the company or organization's annual revenues, with two exceptions (see table).

Other Membership Opportunities for Individuals* (non-corporations)

Basic Professional Member - \$350 annual dues

Professional members must be Managers, Directors, and Vice Presidents of Population Health or in an equivalent role and work in a Hospital System, Group Practice or Clinic, Regional Health Plan, or Academic Institution.

Benefits for individual (non-corporate) memberships, include:

- Networking with professional peers facing similar opportunities and challenges
